A major grant comes to the Chicago Rehab Network

When the MacArthur Foundation decided to honor nine organizations with its new "Creative and Effective Institutions" awards, only two U.S.-based groups were chosen.

The Chicago Rehab Network was one of those groups and will be honored with the other grantees at an Oct. 5 awards ceremony in the Windy City. "In conjunction with the ceremony, the foundation will organize a series of seminars on the work of these organizations that will be open to other non-profit institutions, providing an important opportunity for mutual learning," said the MacArthur Foundation.

"Building and strengthening non-profit organizations has never been more important," said MacArthur President John Fanton. "As the challenges facing our country and world grow even more complex, we look to trusted institutions to help us think about public issues and to galvanize action."

"We are proud to have been chosen by the MacArthur Foundation and we feel this investment shows the importance of our work. The funds given by the foundation will help us provide for the long-term stability of the Chicago Rehab Network," said executive director Kevin Jackson.
"That means our ability to partner with and serve community development corporations and others is greatly enhanced. We love the work that we do and this contribution will help us to do it better."

News that growing numbers of children attending Chicago Public Schools are homeless [''Ranks of homeless CPS students soar,'' Aug. 14] is another reminder that safe, affordable housing isn't a luxury; it's a necessity for a thriving city. And, while appealing for public donations for school supplies is a good idea and noble request, the real appeal should be to the mayor and aldermen to increase the money the city allots to promote and protect affordable housing. Charity is good, but it's no substitute for sound public policy.

The south side of Chicago stands to lose over 9,000 apartments tied to affordable rental housing programs, unless residents, community leaders, public officials and owners get involved, warned the Chicago Rehab Network, before an early June affordable housing summit on the south side. CRN is doing more than handing out warnings. With help from member organizations and leaders, like Mattie Butler of Woodlawn East Community And Neighbors (WECAN), a south side "cohort" has developed.

Congress is focused on a short schedule before fall elections. For the priority issues for September check out the NLIHC Action Alert

See the section that refers to HUD appropriations contained in the Senate bill, but not in the House version. Ask your congressmen and senators to accept the Senate version. It strengthens the Schumer Amendment and extends M2M, plus improvements to Section 8 voucher formulas and mandates that HUD fund all vouchers for all units, not just those "under lease" at the time of opt out.

The Illinois State legislature veto session is coming up in November. Make sure to contact your state elected officials and share stories of the success of affordable housing.
