Support the Janet L. Smith Practitioner in Residence Fund

Dr. Janet Smith was a professor in the Urban Planning and Policy Department at UIC since 1997, the Co-Director of UIC's Nathalie P. Voorhees Center for Neighborhood and Community Improvement since 2004, and served as President of the UIC United Faculty union until early this year. Sadly, our colleague, comrade, and friend passed away January 17, 2022 after a two-year battle with cancer. To honor and continue her legacy, the Voorhees Center has announced The Janet L. Smith Practitioner in Residence Fund at UIC. Practitioner in residence



awards will be granted to experienced professionals who work or have worked in non-profits, academia, and government in the areas of community development and housing policy. The Fund is asking Janet's friends and supporters to celebrate her memory in an enduring way by <u>clicking this link</u> and chipping in what they can to support the program. MEMBER SPOTLIGHT

Chicago Coalition for the Homeless

CCH has continued work on the Bring Chicago Home (BCH) Campaign to enact a one-time real estate tax on homes sold for more than \$1 million that would generate revenue for homelessness programs. The Bring Chicago Home legislation creates a dedicated revenue stream for affordable housing and wraparound services — providing housing for 12,000 families over the next 10 years — by reforming the Real Estate Transfer Tax (RETT) for Chicago properties sold for more than \$1 million. The BCH coalition held a series of four town halls across the entire city to advance the fight for dedicated funding for homelessness. These town halls demonstrated growing support from the community to house people on the streets, in shelters or living doubled-up. Alds. Walter Burnett (27th) and Harry Osterman (48th) became the newest co-sponsors of the proposal. <u>Read more.</u>

On May 20, Bickerdike held a ribbon cutting ceremony for the 100% affordable Lucy González Parsons Apartments in Logan Square. Lucy González Parsons was a labor rights activist of African, Mexican, and Native descent. She dedicated her life to liberating working people from capitalism and racial oppression and led the fight for the eight-hour work day. This project honors her legacy as well as the residents of Logan Square who have fought and will continue to fight for social justice in the community. <u>Find out more</u> and learn how to apply.
