ILHAF Applications Open

The Illinois Emergency Homeowner Assistance Fund (ILHAF) program is now accepting applications for assistance. LHAF provides up to \$60,000 in mortgage assistance to eligible homeowners — paid directly to the servicer, taxing body or other approved entity. Eligible applicants include: homeowners with household incomes less than 150% of the Area Median Income, homeowners who own and occupy their property as their primary residence, homeowners who are past due on their mortgage or property tax payments, and homeowners who have experienced a financial hardship directly related to COVID-19 that began, continued, or worsened after January 21, 2020. We Will Chicago Adopted by Plan Commission

We Will Chicago, a 10-year framework "for promoting equity and resiliency," became Chicago's first citywide plan in more than 50 years with its approval by Plan Commission earlier this month. Guided by three years of public engagement, We Will's 40+ goals and 150 objectives seek to improve economic development, housing, transportation, arts and culture and other subjects affecting Chicago neighborhoods. Applications for FY24 Congressionally Directed Spending Open

Senator Tammy Duckworth will now begin accepting applications for FY24 Congressionally Directed Spending (CDS). The CDS process enables Congress to allocate funding for specific local projects limited to use by units of government, nonprofit organizations and other organizations meeting strict eligibility requirements. For-profit entities are not eligible to participate in the CDS process. Affordable housing construction is eligible. Applications are due at 11pm CT on Friday, March 10th. Visit the CDS portal.
