### Chicago Roof and Porch Repair Program

Each year, funds are available to income-eligible Chicago homeowners to make repairs on their roofs or porches. Interested parties must register in a lottery for a chance to apply for the funds. Registration does not guarantee automatic participation in the program. A lottery drawing will take place in October. Those selected will be formally notified by mail, and their addresses and confirmation numbers will be posted.

## City Looking for Input on New Budget

During September, the City of Chicago will hold Budget Town Halls to solicit input from the community about the upcoming budget for the City. The Town Halls will provide residents with an opportunity to give feedback and ask questions related to the City's 2020 budget. Mayor Lightfoot and the City's Budget Director, Susie Park, will welcome participants and provide a brief overview of how the City's budget functions and how funds are utilized. To guide the information covered in the Town Halls, the City is requesting residents' input.

#### Prices Becoming Unaffordable for Residents Near Obama Center

A new study from the Voorhees Center at the University of Illinois at Chicago examines current housing in the area surrounding the proposed \$500 million Obama Center development. According to the study, prices have risen at a faster rate than the rest of Chicago since 2016 and the area has some of the highest eviction rates in the city.
