Executive Director Kevin Jackson is First Janet L. Smith Practitioner in Residence

We are excited to announce that CRN Executive Director Kevin Jackson has been chosen as the first Practitioner in Residence

at UIC's College of Urban Planning and Public Affairs as part of a new program honoring longtime housing champion Janet L. Smith, who passed away in January of this year. Janet was a professor at UIC since 1997, the Co-Director of UIC's Nathalie P. Voorhees Center for Neighborhood and Community Improvement since 2004, and served as President of the UIC United Faculty union until early this year. She embodied the principles of "community-engaged research and teaching," and her commitment to community development and tireless work for the wellbeing of underserved neighborhood residents is unparalleled.

Practitioner in residence awards are granted to experienced professionals who work or have worked in non-profits, academia, and government in the areas of community development and housing policy. Kevin, a longtime colleague



and friend of Janet, will spend time on campus at the Voorhees Center participating in research, technical assistance, and related programming, as well as interacting with students as professional mentors, guest speakers, and instructors for courses taught in the Urban Planning and Policy Department.

Be Part of the Grounding Values National Study

The Urban Institute has emailed survey invitations to thousands of community-based development organizations across the country. Commissioned by NACEDA, this is the first national survey of community-based development organizations since 2005. It is a critical component in the <u>Grounding Values Study</u>. The results will be used to increase the flow of resources to community development nonprofits. If you are a nonprofit community developer, check your inbox for a survey invitation. It includes your organization's custom survey link. The subject line is "Request to Participate: National Survey of Nonprofit Community Developers." The survey takes about 30 minutes to complete, with questions about your production, programs, leadership, and needs. If you have not received a survey invitation from the Urban Institute, check your spam and ask if anyone at your organization got it. If not, complete this <u>survey request form</u>. The survey closes on October 21.

Volunteer to Help with the Chicago Covenants Project

Racially restrictive covenants and deed restrictions were at one point so widely used in Chicago that it was estimated that 80% of the city's homes were covered by racial covenants. It was a system that was intentionally created, house by house, block by block, and subdivision by subdivision, across the city and across the country. These records have been buried in the files of Cook County, but a new collaboration is

The restriction that no part of said premises shall in any manner be used or occupied directly on indirectly by any negro or negroes, provided that this restriction shall not prevent the occupation, during the period of their embyument, of jaintons or en challeness quarters in the basement or in a barn or garage in the rear, or of servants' quarters by negro janitors, chauffcurs or house servants, respectively, actually employed as such for service in and about the premises by the rightful owner or occupant of said premises.
- The restriction that no part of said, premises shall be sold, given, conveyed or leased to any negro or negroes, and no permission or licetic to use or occupy any part thereof shall be given to any negro except house servants or janitors or chauffeurs employed thereon as aforesaid.

The covenants, restrictions, and agreements herein contained shall be considered as appurtenant to and running with the land, and shall be binding upon and for the benefit of each partyl hereto and may be enforced by any of the parties hereto by any permissible legal or equitable proceedings, including proceedings to enjoin viola-

unearthing the documents to illustrate how racial segregation in Northern cities such as Chicago was not accidental.

The Chicago Covenants Project is working to bring this legacy of racist housing practices to light by bringing together volunteers every two weeks to look through property records and identify racial covenants. 
About CRN
